



### Highlights 9M24

#### **Results Summary**

Consolidated Revenues reached US\$ 1,200 millones / +22.7% c/t 9M23

- $\rightarrow$  Digital Business (US\$ 407 / +29.1%)
- $\rightarrow$  Digital Services (US\$ 381 / +25.3%)
- $\rightarrow$  Transactional Business (US\$ 412 /+14.8%)

Gross Profit totaled US\$ 168 million / +9.2% c/t 9M23 Operating Income reached US\$ 60 million / +16.3% c/t 9M23 EBITDA registered US\$ 104 million / +17.7% c/t 9M23 Net Income reached US\$ 17 million positioning US\$ 8.2 million below 9M23

Consolidated closed deals totaled US\$ 1,257 million / -1.6% c/t 9M23 12-month pipeline reaches US\$ 6,197 million / Brazil represents 45% of the opportunities





### Results 3Q 2024


#### Revenues and EBITDA 3Q 2024




